- Prior to shipment, goods are inspected for surface condition, oxidation level, bundling/strapping, pallet condition and packaging compliance.

- AlloyOne does not engage in manufacturing activities and does not issue factory-level certificates.

5. TRACEABILITY

- AlloyOne maintains batch-level traceability for each shipment, including loading information and shipment identifiers.
- Traceability does not extend to manufacturing processes beyond what is provided by the original production source.
